

## Rules and Regulations

1. **OPEN FIRES:** Fires permitted only in County permitted camp stoves and fire rings provided by the County and only when a burn ban is not in effect. 3.1
2. **FIREARMS:** Brandish or discharge of firearms, pellet guns, BB guns, air guns, bow & arrows, cross bows or archery equipment is prohibited. 3.2
3. **DISTURBANCE OF FLORA:** No collecting, cutting, picking, disturbing, removing, breaking or disturbing any plant, flower, shrub, grass, moss or trees. 3.3
4. **FIREWOOD:** No removal of any log or driftwood larger than 12" in diameter. You may only collect enough for personal use while camping. 3.4 **CHAIN SAWS PROHIBITED**
5. **VANDALISM:** Section 3.5 \*
6. **BLASTING:** Section 3.6 \*
7. **FIREWORKS:** All fireworks prohibited in parks. 3.7
8. **EXCAVATION:** Section 3.8 \*
9. **SIGNS:** Section 3.9 \*
10. **CONCESSIONS:** Section 3.10 \*
11. **OPERATING A BUSINESS:** No person shall operate any business within in a county park or use any portion of a county park for business purposes. 3.11
12. **VEHICLES:** Vehicles prohibited in any area other than main access roadways and campsites. Oregon Vehicle Code applies in parks. Vehicles parked in designated parking shall obey all parking regulations. 3.12
13. **BICYCLES, ROLLER SKATES, SKATEBOARDS AND ROLLER BLADES:** Section 3.13 \*
14. **OFF-ROAD VEHICLES, MOTORIZED TRAIL BIKES, MOTORIZED TWO WHEEL SCOOTERS, THREE WHEELERS AND QUADS PROHIBITED.** Section 3.14 \*
15. **SPEED LIMIT: 15 M.P.H.** where not otherwise posted on in excess of posted maximum. 3.15
16. **METAL DETECTING:** Section 3.16 \*
17. **ANIMALS:** Must be in a vehicle or on a leash not exceeding 6 feet and kept under physical control at all times. No animal is to be left unattended in a county park. 3.17
18. **ANIMALS PROHIBITED:** No animals other than seeing-eye dogs or hearing-ear dogs shall be allowed in any building or structure. 3.18
19. **ANIMAL WASTE REMOVAL:** The owner or person having control of an animal which defecates in a county park shall immediately pick up and dispose of such feces. 3.19
20. **HORSES:** Section 3.20 \*
21. **PUBLIC ADDRESS SYSTEMS:** Section 3.21 \*
22. **PERSONAL MUSIC SYSTEM:** Section 3.22 \*
23. **SOUND SYSTEM AMPLIFICATION:** Section 3.23 \*
24. **SMOKING:** Prohibited in enclosed common use public places (Restrooms, Showers, Service Lines, Cabins and Tee-pees) 3.24
25. **CAMPING LIMITS:** Section 3.25 \*
26. **MINORS:** Section 3.26 \*
27. **CABINS AND TEE-PEES:** Section 3.32 \*
28. **UNDESIGNATED CAMPING AREAS:** Section 3.33 \*
29. **PUBLIC GATHERINGS:** Section 3.34 \*
30. **PERSONAL PROPERTY:** Section 3.35 \*
31. **FISH CLEANING:** No person shall clean fish within county parks, except within the confines of designated fish cleaning facilities. 3.36
32. **SOLID WASTE:** No home garbage. Park users dispose of waste in designated park containers. IF NOT PROVIDED PACK IT OUT. 3.37
33. **SANITATION:** Section 3.38 \*
34. **ALCOHOLIC BEVERAGES:** Section 3.39 \*
35. **INTERFERENCE WITH PARK EMPLOYEES:** No person shall obstruct, harass or interfere with the official duties of County Park employees. 3.41
36. **PENALTIES:** 1-36, Maximum \$720 in fines.
37. **ENFORCEMENT:** Violators of any park ordinance is subject to citation and expulsion from parks when deemed necessary. 4.1



** Transaction Fee (One time fee per site)	** \$11 per Reservation/Registration
** A one-time non-refundable fee is charged on each site for all Reservations & Same Day Registrations. Please add this one-time fee to the first night of your reservation/registration, regardless of length of stay	
CABINS	Base Rate: \$61/night
Cabin Reservations are available online, over the phone, or at Barview Jetty County Campground. Cabin Pet Fee - 2 Pet Maximum - Pets only allowed in cabins 1,2,3,4,5.....\$11 per Pet/ per night	
BROWN Site Marker	Base Rate: \$27/night
Allows 1 tent and 1 vehicle; 1 extra vehicle may be added for \$10 per night 1 extra tent may be added for \$8 per night. Brown tent sites may provide for up to two 10' x 10' tent areas. Campsite limit is 6 people. No RV's or trailers.	
BLUE Site Marker	Base Rate: \$32/night
Allows 1 tent and 1 vehicle (or 1 RV and 1 vehicle if site permits). 1 extra vehicle may be added for \$10 per night, 2 extra tents may be added for \$8 each per night. Blue tent sites may provide for up to three 10' x 10' tent areas. Campsite limit is 10 people. Only 1 RV per Site!	
Back-In RV Sites 28-74 (Full Hook-up)	Base Rate: \$38/night
Allows 1 RV and 1 vehicle. 1 extra vehicle may be added for \$10 per night, 1 tent may be added for \$8 per night. In sites 28-53 and sites 65-74, extra vehicles must park in additional parking. RV sites may provide for up to one 10' x 10' tent area. Campsite limit is 8 people. Only 1 RV per site.	
Pull Through Sites 2-27 (Full Hook-up)	Base Rate: \$43/night
Allows 1 RV and 1 Vehicle. 1 extra vehicle may be added for \$10 per night, 1 tent may be added for \$8 per night. Pull-Through sites will provide for one 10' x 10' tent area. Campsite limit is 8 people. Only 1 RV per site.	
Hiker/Biker Sites	Base Rate: \$9/night
Allows 1 person and 1 tent. 1 extra person may be added for \$9 per night. Hiker/Biker site will provide for one 10' x 10' tent area. Campsite limit is 2 people. No vehicles: used for those traveling via people-power only. Sites G2 and V27 through V34 only.	
RV Holding Tank Dump (All non RV sites and transit can pay by CC at dump station)	Base Rate \$10/RV
Pet Fee	\$6 per Pet/ per Stay - Cabins \$11 per Pet/ per Night
Extra Picnic Tables (limited availability)	Base Rate \$8/table
Shelter Rental (Hours 8am - 8pm)	Base Rate \$125 + \$300 refundable cleaning Deposit

## DEFINITIONS

The term "Hiker Biker" is defined as people-powered travel.

The term "RV" is defined as a Motor Home, Motor Coach, and Travel Trailer, Truck Camper or other self-contained vehicle used for camping that can connect to services.

The term "Tent" is defined as any structure, excluding tent trailer, having non-rigid, non see-through collapsible sides.

The term "Vehicle" is defined as any axle device (excluding an RV) which is legally permitted on Oregon's Highways whether towed or driven. Examples: boat trailers, cooking trailers, cars and pickups are considered

vehicles.

## RESERVATION POLICY

100% of all campsites are reservable.

## RESERVATION PERIODS

Reservations are available year-round at Barview Jetty County Campground, Kilchis River County Campground, Trask River County Campground, Webb County Campground, and Whalen Island County Campground. Woods County Campground offers reservations from May 1st through September 30th. Reservations may be made six (6) months in advance.

## RESERVATION - TRANSACTION FEE POLICY

A non-refundable Transaction fee of Eleven (\$11) Dollars, plus the base rate for the first night will be charged for each campsite reservation.

## RESERVATION CANCELLATION AND REFUND POLICY

- In order to receive a refund of all use fees, minus the non-refundable transaction fee, a person must cancel the reservation three (3) days or more prior to the arrival date.
- If the cancellation is received less than three (3) days prior to the arrival date, a fee equal to one overnight rental fee will be forfeited in addition to the non-

refundable transaction fee.

3. Customers who do not check in at the park office or notify park staff that they will be delayed prior to 1:00 PM of the second day of the reservation will be considered a "no show" and the entire reservation will be canceled. A fee equal to one overnight rental fee will be forfeited in addition to the non-refundable transaction fee.

4. If paid by credit card, refunds will be credited to the credit card account used at the time the reservation was made. If paid by cash or check, a voucher will be credited to the registrant's account on the County Park's reservation system within two (2) weeks from departure date and/or cancellation date.
